Dear Chairwoman Baldwin, Chairman Aderholt, Ranking Member Capito, and Ranking Member DeLauro:

Thank you for your support for critical public health initiatives and the Centers for Disease Control and Prevention (CDC). The undersigned organizations write to thank you for your ongoing commitment to the Chronic Disease Education and Awareness (CDEA) program at CDC and urge you to provide \$6 million (an increase of \$1.5 million) for this program in the Fiscal Year (FY) 2024 Labor-HHS-Education Appropriations bill.

CDC has awarded six competitive multi-year grants to improve public and professional awareness in the areas of hearing loss, lymphedema, obstructive sleep apnea, psoriasis, chronic obstructive pulmonary disease (COPD), and cystic fibrosis. Considering the strong demand for

this emerging program and its potential to support additional meaningful efforts, ongoing growth in the program in FY 2024 is necessary to ensure a competitive process to address several additional chronic health care conditions. More information about this important CDC program can be found here.

A funding level of \$6 million will allow CDC to continue to support ongoing projects and invest in new initiatives that increase public and professional awareness about chronic health conditions that do not have a designated funding line in the CDC budget.
